Description

This course is an introduction to symbolic logic. The main goal is to familiarize you with certain formal methods for representing and evaluating deductive arguments. The course covers both sentential logic and predicate logic, with work equally divided between translating sentences into formal notation, and constructing formal derivations and proofs. Time permitting, we will consider the limits of deductive logic and consider some basic inductive logic.

Homework Assignments

There will be regular homework assignments for this course. A complete list of the homework assignment due dates can be found on the course schedule which is on our course Moodle site. Homework assignments are due by 5:00 pm on the day they are due.

Late homework assignments will not be accepted. A late homework assignment prevents me from posting the answers, which is unfair to other students who have turned in their homework on-time. If you think there are extenuating circumstances that warrant an exception to this policy, you should contact me before the homework assignment is due.

Please staple your homework assignments. Ripped edges and illegible handwriting are signs of sloppiness, so avoid both.

Exams

There are four exams for this course at the end of each of the four units:

Exam 1: 2/24

Exam 2: 3/12 (please note the short window between Exams 1 and 2)

Exam 3: 4/28

Exam 4: 5/10 (finals week)

On Friday 5/2, you have the option of re-taking (an alternate version of) Exam 1, 2, or 3. Your best score will be selected as your grade for that exam. By university policy, Exam 4 must occur during the final exam period, so there is no possibility of retaking this exam.

Portfolio Project

Each student will prepare a portfolio identifying and evaluating the reasoning in five distinct arguments drawn from your everyday reading.

The portfolio will be due on the last day of classes, 5/8. To receive full credit for the assignment you must also turn in a draft of one entry on 3/21, the Friday before Spring Break. The one entry that you turn in must be one of the three deductively valid arguments from the portfolio. I will grade this entry, but the grade is purely for your information. This should help you assess how you're doing on the portfolio before it is due. Though it is not *required* you may turn in up to *three* draft entries on 3/21 and will receive feedback on them. If you fail to turn in any draft entries, your final portfolio grade will be reduced by 10%.

In-Class Extractos

Twice during the semester, we will work in class extracting the argument from short written excerpts. Your task is to extract this argument from the text, and represent it using the logical notation learned in class.

Other Requirements

You should take control of your experience in this course: what you get out of the course will largely be a function of what you put in to it. Logic is cumulative—a lot like a math course. So, it's very important for you to make arrangements to meet with me if you are falling behind or are confused about something. I'm on campus every day and very happy to discuss this interesting material with you.

I expect everyone to attend class, ask questions, and participate in discussions. If no one asks questions, I will assume I am boring you by going too slowly. Consistent with university policy, you may be dropped from the class if absences are too frequent.

I will give clear and prompt feedback on your work.

I will be available for extra help when needed.
